Tourism Economics is a new vendor for this report. Economic impacts for all counties for the past 5 years have been adjusted.

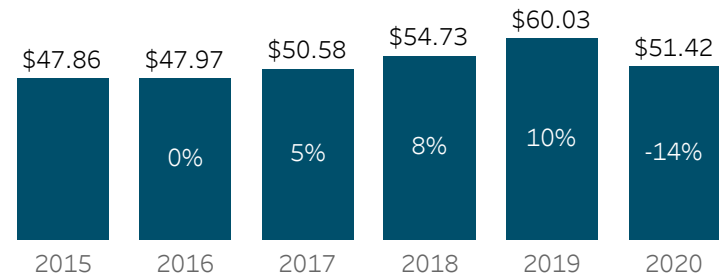

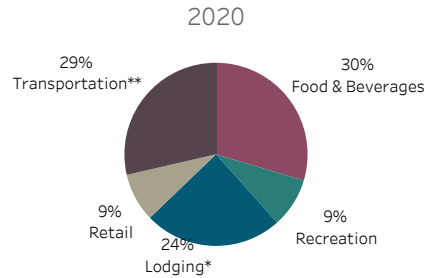
VISITOR SPENDING OVER TIME

IMPACT PER DAY

On an average day in 2020, visitor spending in Roane County generated:

- \$140,484 in daily expenditures
- \$34,990 in daily labor income
- \$6,437 in daily state taxes
- \$5,658 in daily local taxes

IMPACT PER HOUSEHOLD

As a result of taxes generated by tourist activity in Roane county, each household pays:

- \$212 less in state and local taxes
- \$113 less in state taxes
- \$99 less in local taxes

IN OTHER WORDS...

If it were not for state and local taxes generated by tourism, each Roane County household would pay \$212 more in state and local taxes.

RANKING

In 2020, Roane County ranked **28** of 95 counties in visitor spending, compared to 32 in 2019.
